- 3. CEP: Members discussed the current CEP. The public version will remain as is however we will create an internal document which we will make changes to in order to drive instruction. SLT members broke out into subcommittees to look at the action plans for Rigorous Instruction and Supportive Environment and discuss next steps.

problem. Technically we have enough rooms and students are excelling. However, being co-located has proved to be challenging. We want Q300 to get its own building and we're trying to think through what the school needs. We've been meeting with local elected officials, the regional superintendent, presented at CEC30 meetings and the Panel for Educational Policy (PEP). We've been thinking about equity and access for all and possibly changing the way we do admissions. There are more opportunities to build a school outside of this district but we have to remain flexible and logical to think through our options.
